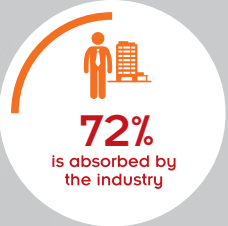
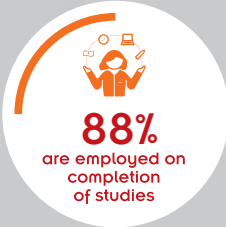

Together we will make a meaningful impact to the lives of these future industry pioneers.

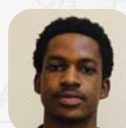
OBJECTIVES

- To address the current and future skills shortage levels in the Commercial Property Industry.



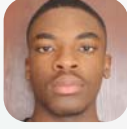

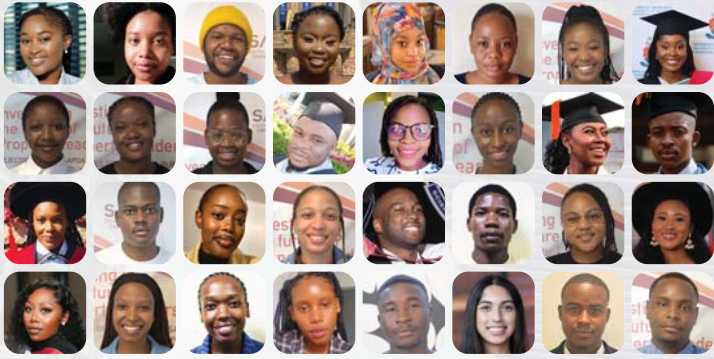
